**\*\*\* LUNCH ACCOUNT INFORMATION \*\*\***

Parents can view their food account activity and pay for meals in one location in Campus Parent Portal. Login to Parent Portal and click on "Food Service" to view your account(s).

Payments to a student/family food service account can be made online, 24 hours a day, directly through Campus Parent Portal. If a child's food service balance is low, you can add money using a credit or debit card.

Online payments are immediately posted to the student's food service account. All credit card statements will show the payment has been made to ISD 728. Families are NOT charged a fee for this service.

In person cash payments (no checks) are accepted before the school day and at meal service.

**\* Please put cash in a labeled envelope (name/s & lunch number/s).**

**\* ALL STUDENTS (with positive account balances) will be allowed to purchase a la carte items, UNLESS the school is notified that you DO NOT want your child/ren to purchase a la carte.** The No 'A La Carte' Request Form is available at [www.isd728.org](http://www.isd728.org) - click on Departments and then Food Service

**\* ALL STUDENTS** will be allowed to take a classroom milk/juice break each day **UNLESS** a note is sent to school stating you **DO NOT** want your child/ren to participate in break each day. The cost to participate in the classroom milk/juice break is listed near the top of this page.

**\* NEGATIVE ACCOUNT BALANCES** - A full-pay student with a negative balance greater than -\$15.00 will be offered a sandwich, vegetable, fruit, and milk per District Policy # 534 Unpaid Meal Charges.
